Authorisation to Open OCBC Statement Savings Account As An OCBC Renovation Loan Servicing Account under the OCBC Home Solution Package

I/We had previously completed and submitted to the Bank an “OCBC Home Solutions Package” application form dated _____ (the “Form”).

The Account is to be used for transactional/savings purposes. I/We acknowledge and agree that the Bank shall be entitled to rely on my/our declarations herein on the beneficial ownership and purpose of the Account.
