TERMS AND CONDITIONS GOVERNING THE "EASICREDIT INSTALMENT PAYMENT PLAN" PROMOTION

- The promotion item(s) (collectively, the "Promotion items" and each, a "Promotion Item") are offered by Oversea-Chinese Banking Corporation Limited ("OCBC") in the relevant "EasiCredit Instalment Payment Plan" promotion(s) organised by OCBC (the "Promotion") at the respective price(s) corresponding to such Promotion Item(s) (collectively, the "Prices" and each, a "Price"). Each of such Promotion Items and Prices are as stated in the application form prescribed by the Bank for the relevant Promotion (the "Application Form").
 - Only customers (collectively, the "Customers" and each, a "Customer") who have opened and maintains in good standing an EasiCredit account with OCBC (the "Eligible Account") are eligible to participate in each Promotion.
